- There is currently no Hampshire Coordinator for 20's Plenty, but Adrian has proposed a Hampshire action group of likeminded Parish Councils and other interested parties.
- ACTION: CC will be our representative on 20's Plenty Hampshire Group and will report on progress.
- ACTION: CC to talk with contacts in Rowledge about Chapel Road (the road with the virtual footway) and how the recent change from 30 mph limit to a 20 mph limit came about.

7. Speed limit enforcement:

- Sgt. Rob Jones, newly police officer appointed to cover our area was invited to speak at the recent Beech Parish Council meeting but was unable to attend.
- ACTION: CC to arrange a visit to Beech for Sgt. Jones, to include GW and Colin Britchford, Beech Neighbourhood Watch.

8. Woodland footpath between Bushy Leaze car park and Kings Hill:

GW reported that on various issues related to the woodland west of the Bushy Leaze car park and it was decided that there were no actions for BRSWG until we hear back from HCC on the scheme safety audit submission.
