## 21.094 APOLOGIES FOR ABSENCE

#### 21.096 CONFIRMATION OF MINUTES - RESOLVED

## 21.097 ROAD SAFETY WORKING GROUP

a) New Footways Project Consultation – 15 consultation response forms have been received to date which is a little disappointing, all Parish Councillors to encourage residents to complete the consultation. The Road Safety Working Group are to provide quotations for the October meeting for Highways Consultant to draw up the proposed footway in a detailed design that can be presented to Hampshire County Council if the consultation response is favourable.

### b) Community Speedwatch

- Hampshire County Council Highways have a special project group that manages traffic speed surveys. The Police
  have suggested that a speed survey be conducted in the Lower Froyle, Bentwoth and Beech areas, possibly using the
  AutoSpeedWatch cameras, so they can further evaluate the issues around the use AutoSpeedWatch cameras in the
  area.
- Police and Crime Commissioner be attending the Hampshire Association of Local Councils AGM this may offer an
  opportunity to discuss the speed issues we face with the PCC. Also note: the PC is trying to get the PCC to attend a
  future PC meeting.
- Speed in the village seems to have reduced to on average 25mph so it may be possible to get a 20mph limit in the centre of the village. However still more than 30 % of vehicles traverse the village at over 35mph some travelling at speeds above 60mph during the hours between 8am and 7pm.
- Gloucester have officially approved use of Autospeedwatch.

#### 21.098 NEW KINGS HILL BOLLARDS

Hampshire Highways in principle understand the point about the type of bollard and would agree to install possibly wooden posts with reflectors in the future. Beech Parish Council to contact Hampshire Highways in the new financial year, April 2022.

Council recognises that we are in a state of climate emergency that requires urgent action by all levels of government, including this Parish council.

With a view to developing and implementing, as its highest priority, a climate emergency response by Council and the Beech Parish community, Council to decide on the following:

- 1. Develop a comprehensive climate emergency action plan with a focus on community-wide engagement leading to:
  - 1 .Emissions (CO2) reduction with Beech Parish being
    - a .Less than the UK average of 13 t CO2e per household by 2030 (-54%)
    - b. Carbon neutral by 2050.
  - 2. Eliminate non recycleable waste (especially plastic) by 2030
  - 3 Increased biodiversity
- 2. Make climate a key focus when making all decisions
- 3. Encourage other councils and higher levels of government to also take climate emergency action
- 4. Appoint a Climate Action Working Group, further discussion at the October meeting on how to launch the working group and potentially hold a public meeting.
