21.143 APOLOGIES FOR ABSENCE

21.144 CONFIRMATION OF MINUTES - RESOLVED

The Minutes of the Council meeting held on 22nd November 2021, copies previously circulated, **Proposed as a true record by Alana Coombes, Seconded by Tony Ransley and RESOLVED**

21.145 DECLARATION OF INTEREST

Alana Coombes, Ruth Duffin and Tony Ransley all declared an interest in item 10. b) Strathyre, 41 Medstead Road.

21.146 ROAD SAFETY WORKING GROUP

The consultation report approved at the meeting on 22nd November 2021 has been loaded on the Parish Council website, there has been minimal positive feedback on Nextdoor.

The Working Group have started to measure the road width and note features that will be used to draw the detailed design of the scheme.

21.147 AUTOSPEEDWATCH - Tony Ransley updated Council.

The autospeedwatch cameras are working but as they rely on solar power this isn't the best time of year.

Several cars have been detected using the average speed check.

The cameras at the Village Hall and on Kings Hill haven't been working properly.

Hampshire County Council radar for the Traffic Velocity and Volume survey is back in the middle of the village as it didn't work properly previously.

Permission has been given to keep the cameras in place for longer, the two cameras that had not been working properly have been moved to new locations and are working well.

Hopefully permission will be given to carry on using the cameras after the 20th December 2021, if possible to use the cameras on an open ended basis to prove the trial data.

The cameras will be moved to the other side of the road.

The highest speed has reduced ty approximately 30%.

The average speed is now below 30mph.

21.148 CLIMATE ACTION

Proposed Alana Coombes, Seconded Ingrid McCormack, RESOLVED (Ruth Duffin abstained) to accept and action the following subject to 60 households signing up for the survey, this will be reviewed at the January meeting.

- 1. Offer a chargeable external Thermal Survey to each Beech householder to:
 - a. Raise awareness of household heat loss and the overall impact on CO2 emissions;
 - b. Identify opportunities for reducing heat loss;
 - c. Drive actions that reduce CO2 emissions from home heating, for example:
 - i. Draught proofing
 - ii. Increased loft insulation
 - iii. Double glazing and or door replacement
- 2. Subject to achieving a minimum of 60 Beech householders committing to the external Thermal Survey by the end of January 2022:
 - a. Contract with the specialist company, <u>iRed</u> for the delivery of the Thermal Survey and production of individual reports for each participating household and an aggregated summary
 - b. Deliver the Thermal Surveys by the 6th March 2022
 - c. Run a workshop with iRed and Alton Energy specialists on the 27th March 2022 to help householders understand their report and identify actions
 - d. To run a follow up email survey with the participants of the Thermal Survey to identify actions taken and results achieved.
- 3. Deliver a set of communications to the Beech Parish with the objective of maximizing participation in the Thermal Survey
 - a. A Thermal Survey sign up leaflet to be delivered to each householder
 - b. A follow on visit by a member of the Climate Action work group
 - c. A set of communications using NextDoor, Facebook and the Parish Council website
 - d. A 'walk in' presence at the Beech Coffee and Cake shop
