ii) 27887/011 Keepers Lodge, Basingstoke Road **NO OBJECTION**

Alternations and extension to an existing garage / annex building and the part change of use to a

1.We ask that a condition be imposed that the section of hedgerow to the east of the building (i.e. immediately behind it, alongside the A339 Basingstoke Road), that was recently removed, be

2.We ask that the Community Infrastructure Levy for this development is addressed, as it is not addressed at all within the application. Two new independent dwellings have been created, and from the description provided the building floorspace has been substantially increased (from the previous single floor garage). We also ask that the council tax/business rates position be addressed for these two new independent dwellings.

iii) 27887/012

Keepers Lodge, Basingstoke Road

OBJECT

Alterations and extensions to the 'Bothy' and change of use to affordable dwelling. **Proposed tony Ransley, Seconded Alana Coombes, UNANIMOUSLY RESOLVED** Beech Parish Council objects to the enlargement and conversion of this building, into an independent dwelling, on the basis of overdevelopment of the site (too many dwellings in close proximity on a single site).

Beech Parish Council also objects to the application to class this property as 'affordable' (for affordable rent). The application provides an analysis that demonstrates that the property has (or is currently) offered at a rent that meets the definition of affordable. However, affordable rented housing also needs to be offered exclusively for rent to local people. The application provides no evidence that that the property's tenants, currently and since conversion, are and have been people with a prior connection to Beech parish or nearby, and there is no commitment to future compliance with this condition.

Neither is there any evidence submitted that the property is affiliated to, or endorsed by, any district-level or county-level affordable or social housing schemes.

We are also concerned that it will not be possible for EHDC to ensure that the property is managed in such a way that it will in perpetuity meet the legal and regulatory requirements for affordable rented housing, including both the level of rent charged and the prior connection of tenants with the local area.

We ask that the Community Infrastructure Levy for this development is addressed, as it is not addressed at all within the application. A new independent dwelling has been created, and from the description provided the building floorspace has been substantially increased (from the previous single room bothy). We also ask that the council tax position be addressed for this new independent dwelling.

iv) 27887/013

Keepers Lodge, Basingstoke Road Affordable 1 bedroom flat (retrospective). **OBJECT**

Proposed Kim Eakers, Seconded Alana Coombes, UNANIMOUSLY RESOLVED Beech Parish Council objects to the application to class this flat as 'affordable' (for affordable rent). The application provides an analysis that demonstrates that the flat has (or is currently) offered at a rent that meets the definition of affordable. However, affordable rented housing also needs to be offered exclusively for rent to local people. The application provides no evidence that that the flat's tenants, currently and since conversion, are and have been people with a prior connection to Beech parish or nearby, and there is no commitment to future compliance with this condition.

Neither is there any evidence submitted that the property is affiliated to, or endorsed by, any district-level or county-level affordable or social housing schemes.

We are also concerned that it will not be possible for EHDC to ensure that the flat is managed in such a way that it will in perpetuity meet the legal and regulatory requirements for affordable rented housing, including both the level of rent charged and the prior connection of tenants with the local area.

22.083 ROAD SAFETY WORKING GROUP

- a) Report from the Beech Road Safety Working Group, appendix A attached.
- b) Proposed Kim Eakers, Seconded Alana Coombes, RESOLVED (Tony Ransley voted against) to:

Approve entering into an agreement with Hampshire County Council for a feasibility study costing £12,500 plus VAT to cover:

- (i) New off-road footways on Medstead Rd alongside Forestry England land (c.650m length in total); and
- (ii) A new off-road footway on upper Kings Hill from Footpath 702 to Alton Abbey (c.405m length).

22.084 SPEED CAMERAS & SPEED INDICATOR DEVICES

-) Tony Ransley reported
- So far this year over nine thousand vehicles have gone 36mph or above this is with the cameras being active circa 50% of the time.
- A resident has volunteered to write to individual companies, maximum of one letter per week, if their company
 vehicles are recorded speeding. The wording of the letter to be agreed by the Parish Council.
- There is an App which allows reporting of untaxed vehicles to the DVLA.
- Top speeding individuals:
 - 1st 102 offences, 2nd 76, 3rd 66 and 4th 58.
 - There are over 40 vehicles who have speeded over 20 times so far this year.
- The Speed Indicator Device recorded the 85 percentile speed as 29mph last week and 28mph this week.
- There is a meeting arranged with East Hampshire Constabulary to discuss how the speeding data might be used to reduce the number of regular speedsters in the future.

The Beech Road Safety Working Group Chairman has apologised in writing to the Parish Council and the Police if the newspaper article in the Alton Herald caused any embarrassment or difficulties.
