23.087 APOLOGIES FOR ABSENCE

23.090 ROAD SAFETY WORKING GROUP

Report from the Road Safety Working Group.

On-road Footway Project

Revised detailed design by HCC continues. Ian Janes was spotted on site last week, so some progress seems to be occurring.

Off-road Footway Project

Last week EHDC confirmed that it would not be providing Strategic CIL Funds for the off-road footway in this year's funding round. In their report, their recommendation is "further working up of this project, to provide a more detailed application for the amount of money sought". So it appears that EHDC is not against the project in principle. Other awards made this funding round were for large amounts of money similar to that which we were seeking, and so the likely amount of CIL funds that we need does not appear to be a problem.

As per our June report, it seems likely that EHDC felt there was too much uncertainty around the project, in terms of both (i) the total project cost (and therefore the amount of Strategic CIL needed), and (ii) how the funding would work, given EHDC's rules on what elements of the project CIL can fund.

We now propose to meet the EHDC CIL Team soon to discuss what we would need to do in order to take the project to the position where it might be funded. This might entail completing more design work so that the project cost can be re-estimated with certainty, before re-applying for Strategic CIL funds. In preparation we have asked HCC to provide a fee quote for getting the design to the necessary stage.

There would also need to be discussions with EHDC and HCC about how any further design work would be funded:

- The use of Neighbourhood CIL would have to be negotiated, as the current EHDC draft guidance is unhelpful regarding its use for design work;
- Meanwhile a different EHDC team has advised verbally that our application for £25,000 from the Supporting Communities Fund
 has reached the final stage for consideration. It is possible that this could be used, if awarded;
- HCC may be persuaded to use their promised £30,000 contribution (or even more) for up-front design work.

So there are several avenues to pursue before we can determine whether a revised application for Strategic CIL can be made next March.

Weight limit on vehicles through Beech

Councillors may recall that last autumn we wrote in support of Medstead Parish Council's proposal to HCC that large vehicles (greater than 7.5 tonnes weight) should be banned from the roads traversing Medstead, apart from for access to property in the area, including all of Medstead Rd, Wellhouse Rd and Kings Hill. The Medstead clerk advises that there has been no response yet from HCC, but at least he is now chasing them!
