25.015 CONFIRMATION OF MINUTES - UNANIMOUSLY RESOLVED

The Minutes of the Council meeting held on 20th January 2025, copies previously circulated, with one correction to 25.011 to clarify 10 bar water pressure.

Proposed as a true record by Ingrid, Seconded by Nikki, UNANIMOUSLY RESOLVED and signed by Chairman Kim Eakers.

25.016 PLANNING

Council to considered one planning application, their comments to be forwarded to East Hampshire District Council

EHDC-24-0027-FUL Land Nw Of Ackender Wood Basingstoke Road

OBJECT

Full planning application for residential development of 99 dwellings (Use classC3), access, informal and formal open space, together with associated drainage, utilities and all other associated works following the demolition of existing building.

Proposed Alana, Seconded Nikki, UNANIMOUSLY RESOLVED: to object to the development as it contravenes the Beech Parish Neighbourhood plan:

- 1. The site is in the area defined in policy BPC03 'Preventing coalescence with Alton'
- The site is not aligned to the Beech Parish local housing needs specified in BPC08
- 3. The Beech Neighbourhood plan is still in force and should not be overridden by the 'presumption in favour of development' due to EHDC's inability to demonstrate a 5 year housing land supply.

25.017 BEECH NEIGHBOURHOOD PLAN REVIEW

Meeting held with EHDC and summary notes circulated. Team will now proceed to review and update our plan. Key decision will be whether we include a housing plan to address an EHDC allocation of 90 houses. This would require a village consultation.

Proposed Ingrid, Seconded Nikki, UNANIMOUSLY RESOLVED: To undertake a consultation with the village on the allocation of homes, currently 90, to be built in Beech over the next 20 years based on the available land. The council agrees to finalise the detail wording of the consultation by email. The leaflet for the consultation to be distributed by the end of February and the consultation concluded by the end of March subject to approval from EHDC to shortened time frame, Detail costs to include printing and village hall hire for public meeting and the council approve up to £200 for these costs.

Our consultant has billed £444.31 leaving just under £560 for further work.
