25.038 CONFIRMATION OF MINUTES - UNANIMOUSLY RESOLVED

The Minutes of the Council meeting held on 17th March 2025, copies previously circulated.

Proposed as a true record by Ingrid McCormack, Seconded by Alana Coombes, UNANIMOUSLY RESOLVED and signed by Chairman Kim Eakers.

25.039 DECLARATIONS OF INTEREST

Ruth Duffin declared a possible interest in item 8. Road Safety and Footpaths Working Group.

25.040 BEECH NEIGHBOURHOOD PLAN REVIEW

a) Housing Site Consultation

Chairman Eakers suspended Standing Orders to allow Graham Webb from the Working Group to update council.

Graham updated -

- 100 responses had been received on paper and online. The consultation closed on the 31st March 2025.
- The results have been analysed and are attached Appendix A.
- The next Neighbourhood Plan will need to allocate some sites to give protection.
- Large sites will be allocated by the District Council, small sites in the Neighbourhood Plan will need to meet the housing requirements in the EHDC new local plan.
- Hopefully housing numbers will be known by the end of the year and the Working Group can then work with EHDC.

Chairman Eakers thanked Graham for his work and reinstated Standing Orders.

Alana Coombes confirmed the Working Group need to arrange a meeting with EHDC to discuss the results and has asked the Clerk to arrange this.

Tony Ransley updated that Strategic Environmental Assessments need to be carried out on every possible site, this could be up to 14 sites. It will be necessary to write to the landowners to ask permission to carry out the assessment.

Proposed Ingrid McCormack, Seconded Alana Coombes, RESOLVED (Ruth Duffin abstained): the Neighbourhood Plan Working Group apply for a grant to fund the Strategic Environmental Assessments.

25.041 BEECH ROAD SAFETY AND FOORPATHS WORKING GROUP

The Working Group have held two meeting to progress what they want to achieve, the meeting minutes will be shared when available.

Chairman Eakers suspended Standing Orders to allow Graham Webb from the Working Group to report.

- Members of the Working Group have carried out a footpath summary walk with Hampshire Countryside Services new warden and the head of Alton Ramblers.
- Any branches and vegetation will be cut back by the Alton Ramblers.
- Two areas where the bridleway surfaces have broken down which may be a project for Countryside Services to carry out the repairs.
 - 1. Bridleway from the top of Wellhouse Road to Thedden, the first 100 metres.
 - 2. Bridleway on the north side of Ackender Wood.
- There are large branches obstructing one footpath, Countryside Services will contact the landowner to get them cleared.
- It has been suggested to ask for volunteers to clear the bus stop area.
- Forestry England are considering what to do with the S106 money allocated to Ackender Wood.
- Kim Eakers will write to landowner thanking them for their footpath maintenance.

 application therefore reducing costs.
- South Warnborough and Lasham may also be considering RTO which could be included in the application and would reduce the costs further.
